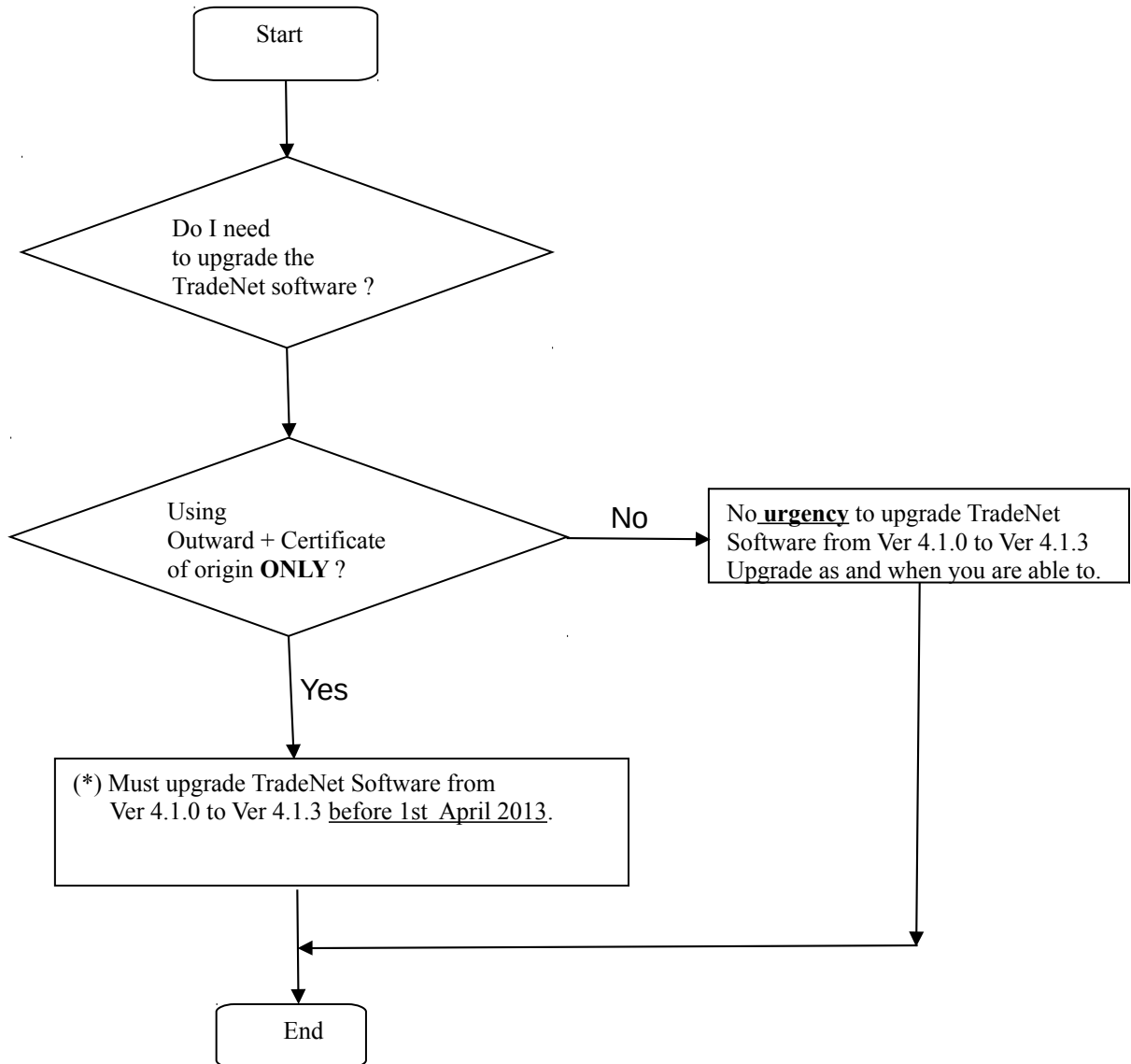

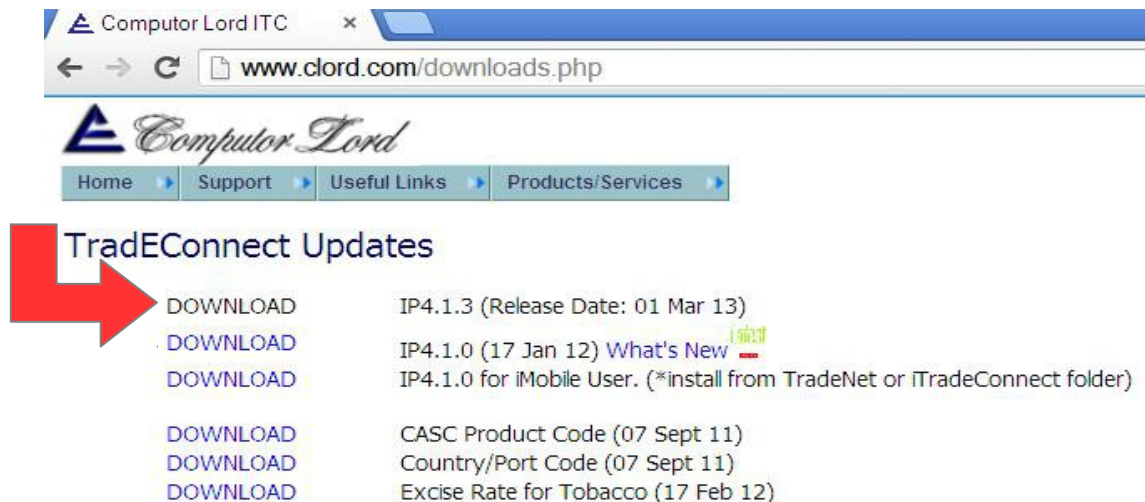
(a) Instructions to upgrade TradeNet software From Ver 4.1.0 to Ver 4.1.3

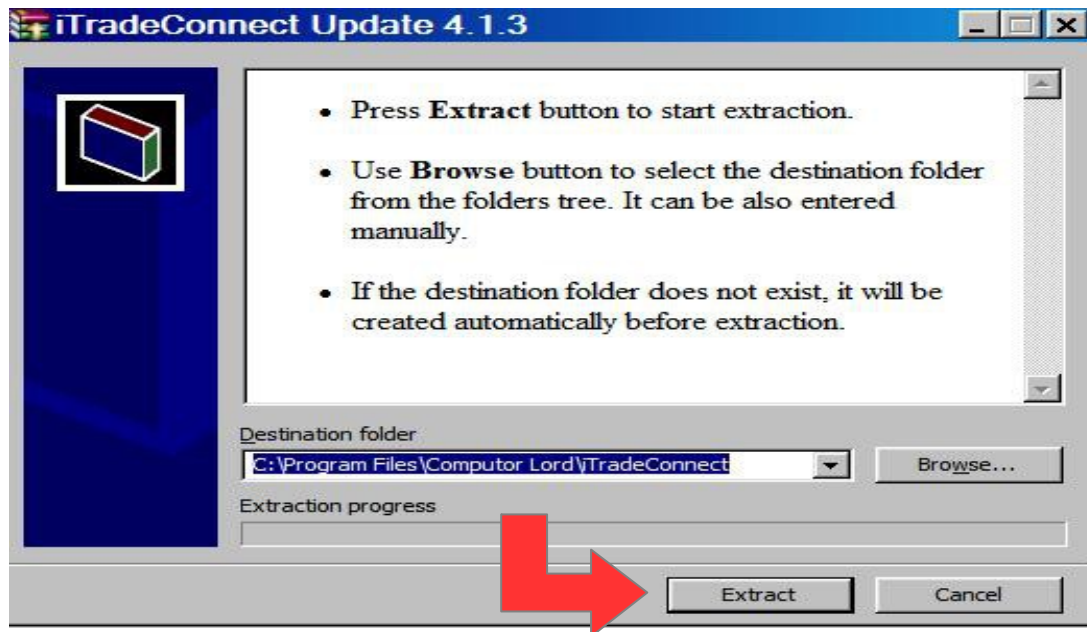
- i. Go to our website : www.clord.com
- ii. Browse to our 'Support' / 'Downloads' section.



- iii. Under the "TradEConnect Updates" - IP4.1.3 (Release Date: 01 Mar 13). click 'DOWNLOAD' and save to your Windows system Desktop.



iv. Upon running/clicking the IP4.1.3, one should see the screen. Just press 'Extract'.



v. End of update.

(b) New features for TradeNet users who wish to do the amendment for Outward + Certificate of Origin.

(i) **New CPC suffixed with '5000' (Deferred Printing of COO)** to enable applicant to request for delayed printing of COO:

Delayed printing of COO will allow traders to:

- have sufficient time to make amendments (to the fields printed on the COO) prior to the printing of COO
- save costs on re-printing the COO

CPC = 5000 is to be declared only if applicant wishes to delay the printing of COO by 2 working days (includes Saturday)

- If COO has not been printed and amendments have been approved, no new Certificate No. will be issued.
- If COO has been printed, any amendments approved for the COO will be issued with a new Certificate No.

Change from "Deferred" to "Immediate" printing of COO

- Request can be made via the "List of Declarations" in Tradexchange Backend.
- Declarant may indicate the request against the corresponding URN and permit number found in the "List of Declarations".
- However, the system do not allow any changes from "Immediate" to "Deferred" as COO would have been generated for printing.

(ii) CPC = 5000 should not be declared if applicant wishes to collect the COO as per current service standard

- Amendments approved for COO will trigger a new Certificate No. to be issued and printed accordingly
